Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution or civil sanctions being imposed depending on the circumstances of the offence.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

A site visit was carried out to ensure the abstraction from a spring at Deer Park Wood was compliant with the conditions in the licence. License holder was present during the visit.

We were unable to assess the flow through the gravity feed pipeline from the spring so we carried out a flow assessment on the inlet to the Hatchery. Using a 14 litre bucket which took 22.19 seconds to fill, this resulted in 0.63 litres per second coming through the inlet. The license holder then explained there are 9 outlets in the Hatchery which we multiplied

by 0.63 to give a result of 5.67 litres/second.

This equates to:

340.2 litres/min

20,412 litres/hr

489,888 litres/day (0.489888 Megalitres per day).

As the quantities of water abstracted are not to exceed 0.68163 Megalitres per day, the flow is within the licensed limit and was assessed as being compliant at the time of the inspection.
