4. Details of our assessment

G1 Monitoring and Records, Maintenance and Reporting - Monitoring of emissions and environment

Quarter 2 monitoring data for Synthite Limited, Mold Chemicals (Alyn Works), Denbigh Road, Mold, Flintshire, CH7 1BF were submitted to Natural Resources Wales in accordance with permit condition 4.2.3.

The following issues were noted with the monitoring.

1. No quarterly monitoring of emissions to air for TVOCs and dust was provided as the Operator couldn't meet the MCERTs standard but suggests conformance will be achieved in Q3.
2. Monitoring of emissions to air for ammonia and formaldehyde has not been completed to the standards required by the permit.
3. Monitoring of emissions to water and groundwater for ammonia has not been completed to the standards required by the permit. This is currently the subject of a permit variation application from the Operator.

Failure to undertake the monitoring in accordance with the environmental permit has resulted in a category 3 breach in contravention of permit condition 3.5.1

Action: Ensure future monitoring is carried out as specified by the environmental permit.
