4. Details of our assessment

This inspection was carried out in response to recent reports of odour (WIRS 2207854) and noise (WIRS 2207527) from the site.

The MRF was not operational and there was no waste stored inside the building.

The operator is due to carry out construction work for a solar farm (not part of the environmental permit) in the fields to the north of the site. They explained that they intend to store some machinery in the MRF building, while the construction work is completed.

There were no issues identified during the inspection.
