4. Details of our assessment

This inspection was carried out in response to recent reports of odour (WIRS 2207854) and noise (WIRS 2207527) from the site.

The older gas engine was operational, the newer gas engine did not appear to be operational.

There was no odour identified near the gas compound.

There were no significant noises identified near the gas compound (operational gas engine was audible but could not be heard approximately 20m from the site).
