4. Details of our assessment

Storm tank

A rotork valve is in operation at the storm tank, desludge frequency is regulated automatically by the inlet

flow. There was visible sludge present and clear signs of the screen being undersized. Wire/power was out for the rotary arm of the tank at the time of inspection, due to an electrical fault. Officers were informed that this is not cleaned periodically, the scrapers are left on auto or unclogged when a blockage necessitates.

MCERTS is measured via Magflow meter on pumped rising main, located after the storm weir near the inlet.

According to 2020 EDM return (permit no 102) there were 138 spills using the block counting method, and for 2021 there were 130 spills. Therefore, this site would be considered to be a high spiller.

Action: could you tell us if this site is being assessed under the SOAF programme and what stage is it at?

It was noted during the inlet inspection [ref: CAR_NRW0039638] that the screen separating storm flow and inlet flow appears undersized for the capacity/population of the works.

Recommendation: Review the operation of the existing storm screen to meet capacity, as it is our opinion that this may be undersized and therefore has potential to cause environmental impact or a non-compliance if left untouched.
