4. Details of our assessment

Review of quarterly monitoring returns

Condition 4.2.3 requires that a report on emissions over the previous quarter shall be submitted within 28 days of the end of the reporting period. Quarter 3 (July - September 2022) returns were received on 26 and 27 October 2022.

Monitoring was undertaken in accordance with Condition 3.5.1.

Efficacy data submitted shows pass for all months in Q3 2022. It should be noted that the efficacy initially failed during September but passed when retested.

Emissions to sewer (flow) July - September 2022 - flow readings provided.

Air emissions monitoring

Emissions to air are monitored quarterly and were received on 26 October 2022.

Monitoring was undertaken as required by Condition 3.5.1 and emission levels are set by Condition 3.1.2 and Schedule 3 Table S3.1.

Q3 monitoring was originally undertaken on 28 September 2022. All results were below the ELVs specified within the permit.
