An unannounced site inspection was carried out at Waterloo CA, Pembroke Dock. The site accepts waste under permit reference EPR/BP3791LA and S1 and S2 exemptions referenced NRW-WME080822.

The weather has been windy over the previous few days and there were showers on the day of the inspection.

A booking system for waste deliveries, implemented during Covid pandemic, remains in place.

The site is well organised with the waste storage areas well signposted, and the infrastructure appeared in very good condition.

The WEEE container was full and was going to be collected the following day. Please ensure the WEEE container is covered with a waterproof covering and provide the documentation showing its removal from site.
