4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales

Environmental Management System and daily inspection records were provided during the inspection. with operations carried out inline with the EMS as required under condition 1.1.1.

Under condition 1.1.3 Any person having duties that are or may be affected by the matters set out in this permit shall have convenient access to a copy of it kept at or near the place where those duties are carried out.

During the inspection staff on site were unable to provide the permit when requested, producing the transfer notice instead. This has been scored as a Category 3 breach of permit.

Action – Please ensure that all staff on site are able to access the full the permit document which identifies the conditions as required under condition 1.1.3.

Action - Please provide evidence demonstrating continued competence with condition 1.1.4 *The operator shall comply with the requirements of an approved competence scheme.*

Operations on site were inline with condition 2.1.1 with no unauthorised activities being undertaken on site. With all wastes stored in appropriate manner as required under the conditions of the permit in Schedule 1 with good segregation and storage of waste types.

All permitted activities were undertaken within the boundary of the permit as required under condition 2.2.1.

Maintenance of site drainage was being carried out during the inspection.

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
