On the 26th of October 2022 a routine sample was taken from the permitted discharge point at Llanelwydd Quarry, Builth Wells

Permit conditions state " The discharge from the site must be free from visible oil and

grease".

At the time of our visit, oil and grease were reported as being visible within the sample, breaching your permit conditions.
