In accordance with permit condition 3.6.1 we confirm the following change to the monitoring requirements, which will remain in force until such time as we confirm otherwise in writing.

For monitoring specified in Schedule 3(b) – Emissions and monitoring effective from 3 December 2023, Table S3.1:

Hydrogen fluoride – Bi-annual monitoring is not required

Mercury and its compounds – Bi-annual monitoring is not required.

You will be aware that the monitoring of these parameters, together with the monitoring of Dioxins/ furans (I-TEQ) has been determined in the absence of proofs described in the BREF document and reproduced in the three footnotes of table S3.1. We will review these monitoring requirements following receipt of such proof/s.
