3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards of Natural Resources Wales.

Wastes were stored in line with the conditions of the permit and identified in the working plan as required under **condition 1.2.1**.

Under condition 1.4.2 a copy of the licence and working plan must be kept on site for referenced when required by staff carrying out works under the requirements of the licence.

When requested staff were able to provide a copy of the working plan, however were not able to provide the permit.

This has been scored as a **category 3** breach of permit for **condition 1.4.2**.

Action – Please ensure that all staff have access to the waste permit as required under the conditions of the permit.

All wastes were stored in appropriate manner and on suitable infrastructure as outlined in **conditions 2.1 .1**.

However, during the inspection, we noted that some of the drainage channels on site were filled with silt which allowed vegetation to grow in some places, this issue was highlighted during the previous inspection and resulted in a breach of permit. Under **condition 2.1.2** of the environmental permit, the engineered site containment and drainage systems shall be inspected, validated and maintained...'.

This has been scored as a **category 3 breach of permit condition 2.1.2** as the amount of silt found in the channel and the growth of vegetation is evidence that no maintenance of the drainage system has been undertaken in some time.

Action - ensure that routine maintenance is undertaken to remove and reduce the amount of build up in the sites drainage channels.

Any compliance criteria not highlighted in the above summary should be considered as not assessed.
