### 4. Details of our assessment

Officers Anna Wilmshurst, Natalie Wrangham, Emily Roe and Elis Nuttall met with Thomas

Hawkes, delivery technician for Severn Trent at Craig Yr Aber Minewater Treatment System. The weather was dry and mild.

Thomas gave Officers a tour of the treatment system. The site is visited 2 times per month and is sampled monthly. The reed bed is stripped out and re-established every 10 years. As there are two reed beds, one can be taken offline at a time. Every 4 years, the reed bed is cut back to remove dead reeds and stop the sludge building up. It was last cut last year. The site is monitored for various determinands, the main ones being pH, suspended solids and iron. The iron limit is 3 mg/l.

The site appeared to be well maintained and no non-compliances were noted throughout the visit. Monitoring data is presented at coal authority liaison meetings. The data was sent through upon request and no non-compliances have been identified.
