4. Details of our assessment

Form S1, Emissions to Sewer, for 1st April to 30th June 2022, was received on 22nd November 2022. It should have been received by 28th July 2022.

A routine Dwr Cymru Welsh Water (DCWW) sample taken on 18th May 2022 showed a zinc concentration above the emission limit value (ELV). Continental Teves submitted a Schedule 1 notification to Natural Resources Wales as soon as they were made aware of breach. This was addressed in CAR_NRW0039986.

All other parameters were within their respective ELVs. The report is accepted.
