4. Details of our assessment

Visit September Cottage on the 28th November at 12:50 and was met on site by a Mr and Mrs Hopson, they informed me that Mr Geoff Ashton no longer lived at the property as he had sold the property about 6 years ago.

Mr Hopson directed and accompanied me to treatment plant which was located on the front lawn, Mr Hopson lifted the inlet work as this chamber was in good working order.

He then lifted the main lid which had the primary, Biological and final tanks, no odour all working well with

the biological tank being fed by air. I did inform Mr Hopson that the primary tank was at it maximum and would need cleaning out, to which he replied that the contractors had already been contacted as this was the time of year he normally has it done, to which he shown me receipts of both the emptying and the servicing dated back to when they moved in.

No sample point, just a junction inspection point.

Outlet pipe located and was in good condition with no signs of sewage fungus.

A very well-maintained plant.
