4. Details of our assessment

Visited treatment plant at Celticbridge on the 28th November at 12:00 after visit to Tir y gof (other side the road) at which Mr Preece confirmed that Mrs King is no longer living at the property as is now in a home.

Access made using top entrance and located treatment plant which was very overgrown and access was very difficult, made access and lifted plant lid to see a small amount of effluent in the plant, no sign of operations, power units seem to be switched off.

Outlet located in the overgrown vegetation, no discharge seen.

Plant seems to be non-operational.
