4. Details of our assessment

On Friday the 25th of November 2022 waste regulation officers Boguslaw Pierzchala and Ian Thomas attended the site.

The site was last visited by Natural Resources Wales (NRW) on 22nd of September 2021, the previous inspection is detailed in Compliance Assessment Report: CAR_NRW0038751. No issues were found.

This was an unannounced, routine inspection.

The site was open with operatives on site performing their duties.

On arrival officers met with Linda Jones, site assistant manager, who accompanied officers during the inspection. Officers were asked to sign in.

Officers were later joined by the yard manager.

Temporary storage of motorcycles was discussed.

They are currently stored outside before being moved. The yard manager explained that the motorcycles are removed from the area usually on the day of arrival and any spillages treated immediately.

Should the motorcycles be stored in adverse weather conditions, such as heavy rain, please consider using a weatherproof cover (i.e. tarpaulin).

The ELV depollution area was checked and at the time of the inspection there were no vehicles being depolluted. The company still only depollutes vehicles on customers' request.

The area was clean and well managed. Waste fluids were stored indoors in separate, marked containers.

Spill granules and kits were located around the site in case of any leaks or spills.

Officers saw batteries storage boxes correctly stored indoors.

The site benefits from several CCTV cameras which cover the entire site. The system has been upgraded recently.

Waste Return Review 2022

Waste return submissions for permit number EPR-WP3394FG has been completed.

At the time of the inspection Q1 2022 was outstanding. It has now been submitted to NRW.

I am pleased to report on this occasion no issues were apparent.

Fire Prevention and Mitigation Plan (FPMP) was discussed. The site benefits from a FPMP which

has been shared with NRW.
