4. Details of our assessment

This Compliance Assessment Report follows a routine site inspection undertaken on 15 November 2022.

The temporary inflatable building for housing the carcass trailer remains insitu. It was noted that there were still gulls in the area, however, there was no evidence of carcasses on the floor at the time of the inspection. The Operator stated that approximately 3 trailers a day leave the site and confirmed that the trailer was covered at night. As stated previously the Operator remains in breach of their operating procedures. **This has been scored as a category 2 breach of Condition 2.1.1 - suspended as the Operator is operating in accordance with their action plan.** The Operator confirmed that the permit application is being progressed using their consultants and it is hoped that this will be submitted shortly.

Avian Influenza has resulted in an increase in the washing down of dolavs, trailers and yard areas. Feathers and a couple of small offal pieces were noted in the rear yard area close to the drains which link to the effluent treatment plant. There was also a chlorine odour in this area.

Advice and Guidance: It was discussed with the Operator that these drains should be regularly flushed to avoid blockages, odour and discourage pests. The Operator should also consider the impact of the additional cleaning on the final effluent discharge.

Netting at the rear of the yard appeared to be in good condition and birds were unable to access the trailers.

Action: The odour scrubber pipe close to the IBC storage area was dripping and requires attention.

An offsite odour review was undertaken prior to the site inspection. No odour was detected on Rectory Road or Church View. No odour was detected around Bernsdale Close or on Phoenix Street. A sewage like odour was detected on Hamilton Avenue from Clair Avenue to Harrison Grove. It could not be substantiated that this was from 2 Sisters.
