2. What action is required?

No action required.

3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

EnerSys were analysing their discharges to water and sewer for dissolved lead (Pb), whereas the contracted analytical laboratory analyses for total Pb. The permit requires the reporting of total Pb concentrations. This discrepancy led to a breach of the emission limit value for Pb emissions to water. A Schedule 5 Notification was submitted and CAR_NRW0040688 required EnerSys to complete several actions to remedy the situation.

Action E3 required EnerSys to analyse for total Pb concentration.

Natural Resources Wales (NRW) believe this was completed shortly after the Schedule 5 was sent to NRW.

Action E3 is complete and can be closed.

Actions C1 and G1 required EnerSys to ensure that analysts are trained in the analytical method for the determination of total lead concentration by 2nd December 2022.

A training card for AS, with the relevant sections completed, was received on 2nd December 2022. There is no reference to the new method, so NRW assume that AS has been trained in the new method.

Actions C1 and G1 have been completed and can be closed.

Actions C2 and G1 required EnerSys to update their analytical procedures by 2nd December 2022 to ensure discharges from W1 and S1 are analysed for total, not dissolved Pb.

Updated procedures were received on 2nd December 2022.

Actions C2 and G1 have been completed and can be closed.

Some of these documents and the covering emails also address actions raised during the recent OMA audit. For simplicity, these will be covered in a separate CAR form.
