Further to agreement made in CAR_NRW0039167 to allow Josh Jones to manage the site without a Technical Competence qualification, it was agreed that due to financial circumstances of the family (who operate the permit) following the death of John Jones to extend the deadline for JOsh Jones to complete his technical competence qualification.

The permit does not have a permit condition requiring you to comply with an appropriate competency scheme as modern permits do and therefore, you are required to meet the requirements of the Environmental Permitting Regulations 2018 Schedule 9. Part 3 (2). This requires you to complete the section on the quarterly waste returns for the site stating who the site TCM is, or else to explain why you have not done this.

Please ensure that you have attained a suitable qualification before 1st January 2023
