4. Details of our assessment

Liz Park (Senior Officer - Waste Regulation) arrived at Nantfforch Landfill to undertake an

unannounced visit to check compliance with the Closure Plan and restoration of the landfill. At the time of the inspection the weather was cold, mainly dry, with light rain.

Liz undertook an unaccompanied site visit. Liz walked around the permitted area and took a number of photographs.

The last compliance visit was undertaken 21 November 2018 and there has been significant changes. The permitted area was in agricultural use and there was no evidence of any recent deposits of waste for the purpose of restoration. The tipping face of the landfill had been regraded and also restored to agricultural use. It is noted that the benches have not been replaced (In 2018 Mr Bowen indicated he would be putting these back into place). Due to the presence of beet and that there was a marked-out motocross track it was difficult to see the lay of the land. There was one area to the west of the site which still showed evidence of the landfill site.

As previously stated, final levels must be in accordance with the approved restoration plan as detailed in Permit condition R.1 (Variation Notice 09/02/2016).

B2 - Closure and decommissioning - Permit Condition C4 - Advice and guidance

Site survey

The closure plan requires annual surveys to be undertaken but none have been completed since 2006. A survey of the site must be undertaken as detailed in Section 4.0 section 4.1.3 of the Closure Plan which forms the agreed closure and aftercare management plan and submitted to NRW within 2 months of being carried out. One this survey has been undertaken. NRW will be able to confirm whether or not the landfill site has been fully restored to final levels.

The survey can be undertaken using traditional survey methods or undertaken by a drone. A drone survey records the ground levels which are then compared to the approved restoration levels using a computer program.

Site stability

The site will need to be confirmed as stable to progress to permit surrender. Section 4.1.2 of the closure plan required survey monitoring points. None have been established.
