4. Details of our assessment

This was a pre-arranged familiarisation visit of the Facility by the Natural Resources Wales (NRW) regulating Officers.

A short introductory meeting was held with Steven Swygart and the Plant Manager, before NRW Officers were provided with a high-level tour. The following locations were covered during the tour:

- The general cable production areas
- The lead melting and coating process
- The settlement lagoon
- The oil and waste oil storage facility
- The materials store

The salient points following the meeting and high-level tour are as follow:

The process is not operated on a continuous basis (run on demand), as a result the Permitted lead melting and coating process was not running at the time of the visit. The Operator confirmed the last time it was operational was October 2022; it is next due to be operated early December 2022.

Lead ingots are typically stored in the materials store, however at the time of the visit lead was not being stored.

Wastes within the process areas are segregated in clearly labelled "bins". Segregated wastes are sent for recovery.

The oil and waste oil bulk storage tanks and associated bunds were observed. Evidence of oil leaks, spills and staining were noted outside the bund. Some water was observed in the bund, but it's integrity could not be ascertained. The Operator was unable to confirm if integrity testing of the bund was undertaken.

The waste metal skip bund was observed to contain water and possible metal cutting fluid waste. At the time of the visit the Operator was unable to confirm the procedure for management of water in this bund.

The settlement lagoon is fed by roof run-off and recirculated process water via site drains, biocides are added to minimise fouling. When necessary, the settlement lagoon is cooled by the addition of towns water. When levels become too high in the settlement lagoon, water is directed via penstock and culvert to the River Clywedog. The headwall at the River Clywedog was observed and there were no apparent contaminative discharges.

Seagulls have been a pest issue in the past and the Facility contracts a local bird of prey handler to deter the gulls from nesting and the roof.

Recommendations

- Review and where necessary update housekeeping and procedures with regards to

oil and waste oil storage.

- Review and where necessary update housekeeping and procedures with regards to metal skip bund.
