An unannounced site inspection was carried out on 2 December 2022. The weather was dry during the inspection.

AWD operate under a Standard rules SR2008 No3 - household, commercial and industrial waste transfer station with treatment and have registered a number of exemptions:

NRW_WME065361

- T1 - Cleaning, washing, spraying or coating of relevant waste (Non-agricultural)
- T4 - Preparatory treatments (baling, sorting, shredding etc) (Non-agricultural)

NRW_WME064792

- S1 - Storage of Waste in Secure Containers (Non-agricultural)
- S2 - Storage of Waste in a Secure Place (Non-agricultural)
- T12 - Manual Treatment of Waste (Non-agricultural)

AWD Group has applied to NRW for a permit variation.

As part of ongoing infrastructure improvements to the site, a new drainage containment tank, fed via a silt trap has been installed. Investment also been made in new equipment to process plastic.

ACTION: Please provide a plan of the site showing areas of the site that are operating under an exemption and the areas that are operating under the permit.

Oil storage

Two 45 gallon metal drums believed to contain hydraulic oil for the onsite plant, were not being stored within a bund or on a drip tray. Section 5.5 of your Environment Management System states 'Drums and cans containing oil will be located on drip trays (where appropriate) or in bunds capable of containing a minimum of 110% of the volume of stored oil.' This is a breach of condition 1.1.1 of the permit and has been recorded as a Category 3 breach under - B4 containment of stored materials.

Action: Store all oils as per permit requirements.

Non-conforming waste.

Paint tins (plastic) are not authorised under the permit (or exemptions) and should be handled as a non-conforming waste.

Action: Please ensure the procedure 001 set out in the EMS is followed for non-

conforming waste.
