Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

The OMA audit on 26th October 2022 revealed several areas within EnerSys's policies and procedures that could be improved. EnerSys have already addressed some of these areas and Natural Resources Wales' (NRW) responses and comments are given below.

EnerSys have identified a suitable training organisation and relevant personnel will be attending courses for on-site auditing and regulatory monitoring requirements in March and April 2023. This should help to improve future scores for Elements 1E - Understanding of the permit and monitoring methods and 4F - Reporting.

Auditing of monitoring (Elements 4D and 4E) had not been carried out. EnerSys have provided an audit schedule, showing the planned audits for all contractors involved in monitoring and analysis. This will help to improve future scores for both elements. The due date was 30th November 2022 and the schedule was received on 1st December 2022.

The chain of custody for water and effluent samples sent to an external laboratory has been shortened and documentary evidence for each part of the chain is now in place. The analytical results will now be sent to EnerSys, rather than a third party and EnerSys have requested that the turnaround time be improved. These actions will help to improve future scores for Element 2A - Sampling provisions.

Sampling methodology and pH measurement still require some clarification before NRW can agree that they have been sufficiently improved.

NRW have received a training card for one of the laboratory personnel. It is not clear which version of the procedures they have been trained in. The training card could be improved by adding the relevant procedure's issue number and the date the training was carried out. The due date for completion of this action is 31st December 2022. NRW would also like some assurance that more than one person is trained to carry out sampling and monitoring duties.

EnerSys have taken the results of the recent OMA audit very seriously. Their prompt actions in arranging training in auditing and monitoring methods and shortening the chain of custody issues are appreciated.
