3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

During a tanker filling operation on 7th March 2022 the tanker overfilled, spilling biphenyl over the tanker and onto the surrounding area. Biphenyl solidifies on contact with air and so the spillage was limited to the side of the tanker and a small area of the surrounding concrete hardstanding. The spillage was cleaned up.

Natural Resources Wales (NRW) received a Schedule 5 Part A Notification on 8th March 2022 and a completed Part B Notification on 29th November 2022. Eastman had completed an internal review, identified the reasons for the failures and implemented the appropriate corrective actions, (detailed above).

Action: Send the updated tanker filling procedures to NRW by 27th January 2023.

As part of a future inspection, NRW would like to discuss the details of this incident, including how it happened, the immediate actions taken and how the corrective actions will reduce the likelihood of its happening again. NRW would also like to know if this was the first time this incident had occurred and if so, Eastman's opinion on why it happened at this particular time.
