4. Details of our assessment

This Compliance Assessment Report (CAR) form has been raised due to a review of the Quarter 3 monitoring returns (July - September 2022).

Monitoring returns were received on 24/10/22, within the timeframe required by Permit Condition 4.2.3(b). All monitoring required by Permit Condition 3.5.1 was conducted and reported as per Permit Condition 4.2.3(a).

All reported parameters were compliant with specified emission limits levels.

There was a notable type error of the result for Acetone (DMK) which was listed as <50 g/l GCMS-TM83/PM10. This should read <50 ug/l, please ensure submitted returns are checked for typographical error prior to submission.
