3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

You are non-compliant with your permit.

At this time, we are issuing you with a warning for the non-compliance recorded above. Warnings may influence future enforcement response for continued or further non-compliance.

This statement does not stop us from taking additional enforcement action if further relevant information comes to light or offences continue.

4. Details of our assessment

Weather: Overcast and light rain.

This was a routine inspection as part of Natural Resources Wales' Closed Landfill Project, the aim of the inspection was to determine compliance with the sites' environmental permit and supporting documents. Findings of the inspection are set out below.

Groundwater and landfill gas monitoring points: A selection of groundwater monitoring points were inspected. BH4 intact; BH1 intact; BH2 not present; BH3 intact; GW3 intact; GW2 not present; and, MW4 intact.

Action: Submit to Natural Resources Wales a plan for the re-instatement or repositioning of BH2 and GW2 within 6 months of the receipt of this Compliance Assessment Report.

Recommendation: Label all un-labelled monitoring points clearly.

No landfill gas odours were detected or was there any unusual vegetation die back around the monitoring points.

Leachate monitoring points: None present.

Landfill gas extraction points: None present.

Landfill surface: Landfill does not appear to feature an engineered cap or restoration layer. During the site inspection and walkover the land mass appeared to showing signs settlement, cracks, movement and exposed waste material such as metals and cables and there was staining at the toe of the waste mass at some points.

Surface water: The outfall of the drainage ditch in the north of the site was not observed.

Action: Make an assessment of whether the landfill needs to be capped and restored and report back to Natural Resources Wales on the outcome of your assessment within 6 months of the receipt of this Compliance Assessment Report.

Environmental permit: A full copy of the environmental permit was not available on site.

Any person having duties that are or may be affected by the matters set out in the permit must have convenient access to a copy of it kept at or near the place where those duties are carried out.

Action: Natural Resources Wales: To supply a copy of the environmental permit (attached). Blue Circle Cement: For completeness, to supply the original working plan and the 2001 site investigation for review within 6 months of the receipt of this Compliance Assessment Report.

Gas utilisation plant and flare: None present.
