The inspection highlighted a number of issues with your paperwork which require improvement:

Inspection and Maintenance Records

You are recording maintenance and repairs, but you should also be recording the regular inspections that you are carrying out.

Training

You are keeping records of when training has been undertaken by staff members. A training plan should include what training needs to be completed by all staff members, when it has been done, and crucially when the training needs to be repeated.

Accident Management Plan

Your accident management plan is very basic and should be updated. It should include an accurate site map, and an up-to-date list of contacts and phone numbers.

Site Plan

Please send me a copy of your site plan. The one which we currently have on file is the one which was produced as a part of your initial application. It should also be included in your Accident Management Plan.

Reviewing the Paperwork

All paperwork should be reviewed on a regular basis and updated as needed. The date of review should also be updated and recorded. For example, in word documents it's easy to use the footer as a place to record (and update) the review date.
