3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

This Compliance Assessment Report (CAR) follows a routine site inspection at Wrexham Convivence Foods/ Rowan Foods on 06/12/22.

There have been several staff changes since the last site inspection. The new Group Sustainability Manager and Health, Safety and Environment Manager were present during this inspection. Updated site contact details were provided to NRW following the inspection.

The Effluent Treatment Plant (ETP) has been upgraded since the last inspection. Site staff gave an overview of operations and sampling procedures. Permit condition 3.5.1 (Table S3.2) requires that weekly visual spot checks of emission point W1 are completed (no visible oils and/or grease). It was agreed with the operator that photographs taken at the time of the checks would be satisfactory evidence that these checks had been completed.

Action 1- Action only- Ensure photographs of emission point W1 are taken during the weekly spot checks.

The emission points for the ovens and boiler stack were inspected. No odours or dust observed.

Following the issue of the consolidated environmental permit on 09/02/22, the operator was required to complete the following Improvement Condition

'Improvement Condition 10 (IC10)

(a) The operator shall submit to NRW the maximum capacity of the installation that was used in the most recent risk assessment submitted to NRW.

(b) The operator shall submit to NRW for approval the maximum capacity of the installation at the current time.

(c) If the maximum capacity of the installation has increased from the time of the last submitted risk assessment and the current time, the Operator shall review and update the risk assessment to account for the current maximum capacity. The risk assessment shall be submitted to NRW for review.

(a) and (b) within 6 months of permit variation issue. (C) within 9 months of permit variation issue (if applicable).'

The operator submitted data for maximum operating capacity of the installation (IC10) to NRW on 01/12/22. This is after the timeframes specified by the permit and NRW considers this a breach of permit condition 2.4.1 (G4-CCS4).

Action 2- Please review the data submitted to NRW on 01/12/22 in relation to maximum capacity of the installation (IC10) and confirm this is correct by the specified date.
