4. Details of our assessment

Impoundment structure measured, found the abstraction screen width and residual flow width correct, however, depth of notches were measured deeper than detailed on drawings. It appears that the depth for the abstraction screen should be 50mm but was measured as 100mm, and the same for the residual flow notch. Screen aperture measured and is correct.

Action

Measure and submit correct depth of notches. If measurements are different to drawings on licence, then licence variation will be required.
