In your previous CAR NRW0039864 you were given actions for completion by 31st August 2022 which were not completed to the original deadline for reasons that we accept have caused a delay.

On 3rd November 2022 you met with my colleague Ffion Thomas, in the South West Wales Industry Regulation team, for pre-application advice to discuss a way forward to bring the activities taking place under this permit, EPR-3099CG, under your Anaerobic Digestion plant permit EPR-3233DW.

Further to the advice you have received at this meeting and the exchange of emails between Lucy, Paul and myself you have agreed to submit a variation to the AD permit and a surrender for the waste permit during week commencing 16th January 2023.
