## 4. Details of our assessment

This was a routine unannounced compliance visit carried out by Malcolm Dines and Gillian Coates, who met with Evan Jones, the site owner and Technically Competent Manager. The weather was cold but dry, with ice on the ground and Mr. Jones accompanied us around the site for the duration of the visit.

### Permit Breaches

C4 - Storage, handling, labelling and segregation - Cat 3; Permit Condition 2.1.1

You have been given this breach under the above condition because at the time of the site inspection there were still around 10 undepolluted End-of-Life Vehicles (ELVs) stored on hardstanding, rather than on impermeable pavement with sealed drainage. At present there is no evidence that any of these vehicles are causing pollution or are in a condition that suggest they are a significant risk of causing pollution. It is also accepted that you have been busy with significant infrastructure improvements however, there are still vehicles stored on the area of impermeable pavement at the site that are not waste and therefore that space could be used to store undepolluted ELVs.

Actions - ensure that all undepolluted ELVs are stored on impermeable pavement with sealed drainage. A deadline of 30th June 2022 has been specified for this action to be completed.

### Other general observations/comments

The remaining outstanding compliance actions have been completed now that you have gained your Technical Competence qualification. Please remember that you are required to complete the relevant Continuing Competence training every two years and your Environmental Management System should ensure that you have a reminder for this to be completed.

The site is looking much improved, and it is clear that you have established a solid management procedure at the site while retaining support from other professionals within the waste industry to maintain the level of quality.
