4. Details of our assessment

This compliance assessment was carried out by Malcolm Dines to assess compliance with

the requirement to monitor and report bioaerosol emissions at the site. The Bioaerosol Monitoring report was submitted to NRW by the operator on 20th December 2022.

The report details that the monitoring was carried out in accordance with NRW's M9 Technical Guidance that was published in 2018 and which replaced the older guidance required by permit condition 3.5.1 (referring to Table S3.2).

The report shows that bioaerosol emissions on the day of the sampling were within the limits set out in the permit.
