4. Details of our assessment

Natural Resources Wales officer Julia Lloyd met with poultry operators Frances and David and consultant

Gail Jenkins at Upper Esgair Farm Poultry Unit to carry out a routine poultry inspection on the 25-11-22 at 11am. Many thanks for your time during the inspection.

Actions –

Spreading on own land – manure and slurry nutrient analysis – Where manure and slurry is spread on own land, they must be analysed to provide information for nutrient management planning. Records should show that analysis is carried out twice yearly, or once per production cycle where that cycle exceeds six months. The analysis should include available nitrogen, total nitrogen, available phosphorus, and total phosphorus. You confirmed that this has been carried out and are awaiting the results. **Please provide the report or an update to NRW by the 30-01-23**
