**ACTION**

No current action as measures already taken and turbidity sampling data submitted.

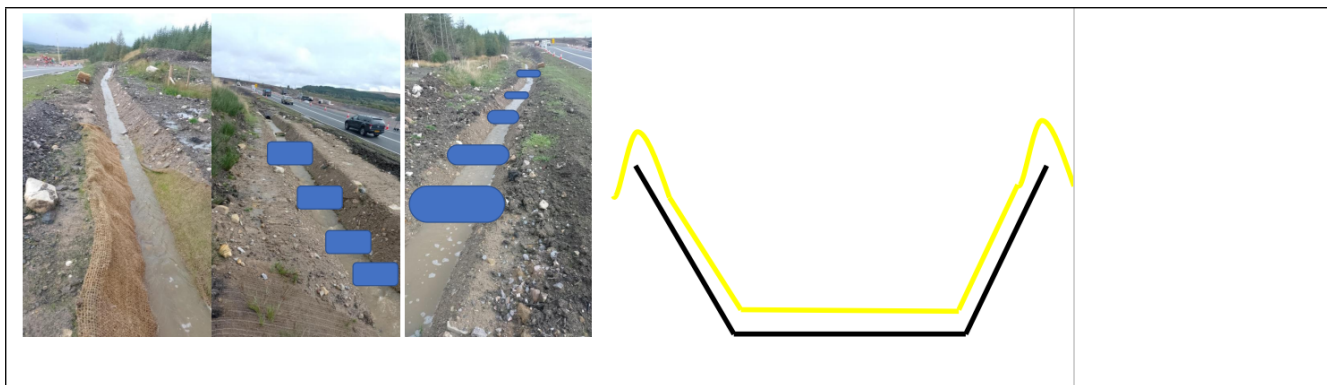
Swansea Road / Nant Ffrwd discharge

Turbidity of 212 NTU identified (limit approx. 75 NTU) due to insufficient capacity of the water management system (Siltbuster). Measures to be taken:

- Increase size of dosing system (more than double from 8m³ to 20m³)
- Triple the size of settlement system.

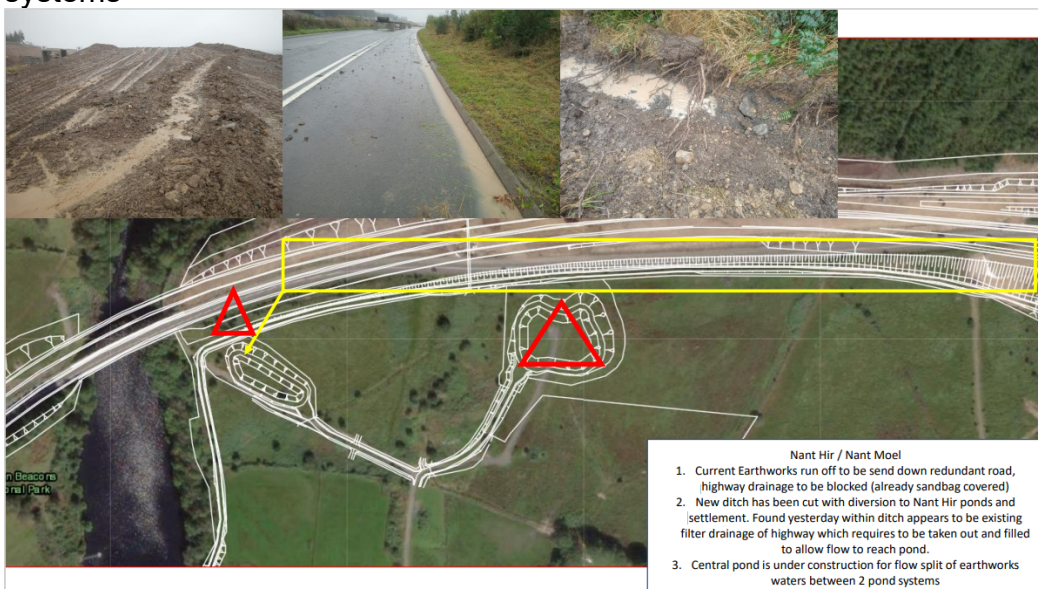
Baverstock North (Nant Hir / Nant Moel)

1. Remove down erosion matting
2. Replace liner with terram sheeting, dig down sheeting approx. 50mm from edging to encourage water flow over and into drain
3. Placement of erosion matting over the top take out coarse material
4. Placement of wattles in drain to remove / filter excess left within drain upon next rainfall



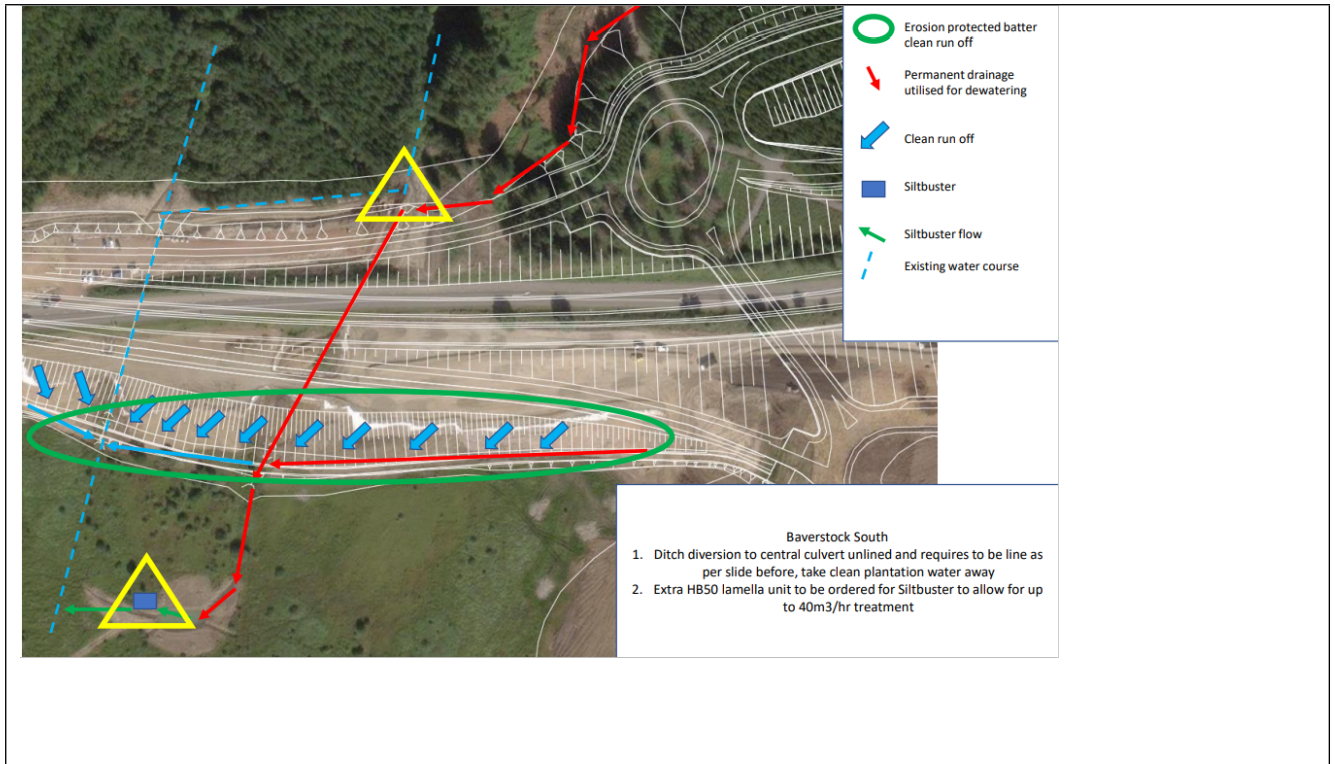
Nant Hir / Nant Moel

1. Current Earthworks run off to be send down redundant road, highway drainage to be blocked (already sandbag covered)
2. New ditch has been cut with diversion to Nant Hir ponds and settlement. Found yesterday within ditch appears to be existing filter drainage of highway which requires to be taken out and filled to allow flow to reach pond.
3. Central pond is under construction for flow split of earthworks waters between 2 pond systems



Baverstock South

1. Ditch diversion to central culvert unlined and requires to be line as per slide before, take clean plantation water away
2. Extra HB50 lamella unit to be ordered for Siltbuster to allow for up to 40m3/hr treatment
