## 4. Details of our assessment

Improvement Condition 2 (IC2) requires the operator to:

'Provide fuel storage that meets the requirements of 4.2.1 of Environmental Permitting Technical Note 5/1(18), Final Draft, dated 15/08/18 for all fuels that are used in combined heat and power boiler (activity reference AR1 in Table S1.1 of this permit). All fuel shall be stored under appropriately designed cover which shall ensure that it is kept dry and that ingress of rainwater is prevented. Storage shall be suitably sized to provide sufficient capacity, having regard also for other relevant factors such as the separation of different fuel types and sizes as required operationally.

The Operator shall submit to Natural Resources Wales for approval, prior to commencement of construction, a report detailing the specification and design of the covered fuel storage area(a). Prior to construction, the Operator should satisfy themselves they have all other required legal permissions which may be required for construction of the storage facility.'

The operator submitted designs for the proposed fuel bunkers to NRW on 25/11/22. These designs show fuel bunkers constructed out of concrete blocks with associated concrete surfacing. NRW requested additional information regarding the roof design/ specifications.

The operator provided NRW with detailed specifications for the roof / covering material on 07/12/22. NRW requested additional information regarding the drainage arrangements to ensure water ingress is prevented.

The operator provided NRW with an update on the drainage arrangements on 22/12/22. The concrete surface falls away from the water course and towards the non-concreted permeable surface of the site. The water is then dealt with via the original soakaway system. The gutters from the new proposed roof will be directed into the original surface water outlet manholes connected to the original building.

Based on the information submitted to NRW, we are satisfied that the proposed design meets the requirements of IC2. Construction may therefore commence in accordance with the information supplied.
