4. Details of our assessment

On 24th November 2022 Eastman/Solutia submitted a Schedule 5 Notification to Natural Resources Wales informing them that there had been a discharge of site effluent during the "cease discharge" period due to heavy rainfall in the preceding days. This had caused elevated levels in the effluent lagoons and so they were pumped out to avoid the site flooding. The discharge was analysed and all parameters were less than their respective emission limit values. The risk to the environment was therefore minimal.

Due to the unforeseen nature of the incident and the minimal risk to the environment, no non-compliances have been issued.
