We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

A site inspection was undertaken on Friday 16th December 2022. The purpose of the

inspection was to assess infrastructure improvements that you were required to make following issues identified in previous inspections of the site (Friday 18th March 2022 & Friday 20th May 2022).

Present at the time of the inspection on Friday 16th December 2022 were David Morgan (Natural Resources Wales) and Laura Terry (Tegfan Recycling).

The following observations were made:

Infrastructure

In previous inspections (Friday 18th March 2022 & Friday 20th May 2022), Natural Resources Wales had identified issues with infrastructure (boundary fencing) that was failing to prevent waste escaping site.

On Friday 16th December, it was noted that works have taken place to the rear of the site (rear upon entering) where wood waste is stored. The rear fencing has been replaced and netting has been installed to prevent wood waste and other wastes escaping site. An inspection of the boundary at the rear of the site suggests this has been successful in preventing the escape of waste from site in this area.

On the left hand side of the site (upon entering site), where inert waste is stored, boundary fencing is failing to prevent the escape of waste from site. Inert wastes (soil, stone etc.) are escaping site. This is a significant issue as waste can enter a nearby watercourse, which feeds the River Neath. Also, during periods of heavy rain, surface water run-off from site may result in silt pollution.

A non-compliance was recorded against condition 2.4.1 of the Environmental Permit (Category 2 - Significant) (Ref:B4)

Infrastructure must prevent the escape of waste from site. **The due date for this action to be completed has been set for Monday 17th April 2023.**

As this issue has not been resolved following previous inspections, it is likely that Natural Resources Wales will issue a Regulation 36 Notice enforcing compliance with this condition.

Summary

Despite making some improvements to infrastructure in recent months, there remains an issue with boundary fencing failing to prevent activities extending beyond the permitted boundary. It is likely that Natural Resources Wales will issue a notice enforcing compliance with the Environmental Permit.

You must resolve this issue by Monday 17th April 2023. Failure to do so may result in enforcement action being taken against you.
