4. Details of our assessment

Kennametal accept used ceramic boats from their customers for re-processing. These boats are production residue from the evaporation of aluminium. They are sent from overseas and are, at no

time, shipped as waste.

The boats are sent to a third party for cleaning and then returned to Kennametal for further processing. All of the operations are normal manufacturing operations, not waste treatment operations.

Kennametal are not permitted to accept or treat waste and therefore they do not need to apply for any waste treatment permits or exemptions. However, this may change in the future should further information become available.
