Following a leak of dilute sulphuric acid from an IBC in NP2 on 4th November 2018, The Royal Mint were asked to implement the following actions.

Send Natural Resources Wales (NRW) photos to confirm completion of secure storage facility for IBCs containing waste acid/alkali awaiting collection by waste disposal contractor.

Action: *Send NRW photos of completed storage facility by 14th December 2018.*

Photos were received on 13th December 2018. **This action is complete.**

Formalise existing policy on IBC integrity checks. Send NRW a copy of the procedure.

Action: *Send NRW a copy of the revised procedure by 14th December 2018.*

The draft procedure was received on 13th December 2018 and is acceptable. **This action is complete.**

Repair & resurface part of concrete floor in NP2 damaged by sulphuric acid. Send NRW photos to confirm work has been completed. **Action:** *Send NRW photos of repaired floor by 14th December 2018.*

The floor has been repaired but cannot be repainted until the Christmas shutdown. NRW are confident that the repair will be completed properly and will therefore close this action. The Royal Mint will send photos of the completed repair after Christmas. **This action is complete.**
