Celsa advised NRW on 31st October 2018 that there is a significant quantity of scrap (redundant equipment estimated to be ~300t) that has been stored on the Castle Works site but which is outside the installation boundary. Before this material can be recovered in the EAF it needs to be cut up into a manageable size. Celsa have requested permission to complete this work over an estimated three week period.

Permission is granted by NRW to complete the work on the basis that:

- fugitive releases are minimised such that there is no environmental impact
- necessary precautions are taken to avoid/prevent any ground contamination
- work is only carried out during normal day time operational hours
- in the event that NRW are advised of an adverse environmental impact the work is suspended
- NRW is advised when the work is complete.
