4.2.1 (i) Assessment of the settlement behaviour of the landfill body

Settlement monitoring points have been established on the restored areas of the site to ensure settlement behaviour of the waste in the landfill site is recorded.

The selected points will be monitored at a minimum time period of once a year, but it is envisaged that the frequency is likely to increase to three times a year in newly capped areas. For reference purposes the settlement monitoring point locations will be marked on the "Settlement Monitoring Plan" as listed below.
