### 4. Details of our assessment

On 02 December 2022 the Fire Prevention and Mitigation Plan version 4 was submitted to NRW for review.

This FPMP included a revision of the stockpile sizes, which were adjusted for the available water on site. In the event of a fire there is still an estimated 20m<sup>3</sup> shortfall of water

supplies, however this has been deemed acceptable by NRW and FRS on consultation.

There are two minor wording queries which need to be addressed and added to the plan, as discussed via email to Nening Jones on 20 December 2022:

1. Out of hours availability of staff for machine operation
2. Assurance the IBCs are maintained and kept full and safe to use, i.e. not stagnant or contaminated.

The contents of the plan and the contingency measures in place have been written in line with the current NRW Guidance on Fire Prevention and Mitigation Plans, with the wording queries above included, therefore NRW accepts this plan for the Scrapyard site.

Please provide the updated plan to include the relevant wording as above by the 31 January 2023.
