4. Details of our assessment

BREACH OF SUSPENDED SOLIDS AND BOD PERMITTED LIMITS

A Schedule 5 notification has shown breaches of permit limits for effluent discharge from your facility into to the Afon Erch. The breaches in question on this occasion are for suspended solids and BOD. These breaches were sampled on the 22nd December 2022. Permit condition 3.1 states:

3.1.1 There shall be no point source emissions to water, air or land except from the sources and emission points listed in schedule 3 tables S3.1, S3.2 and S3.3.

3.1.2 The limits given in schedule 3 shall not be exceeded.

The limit for suspended solids is 30mg/l and the value reported was 59.3 mg/l. The limit for BOD is 20mg/l and the value reported was 22mg/l.

The Suspended Solids and BOD results are a breach of the permitted limits and in the context of this discharge have been scored once on this occasion. *As such this is considered a minor breach and is scored a CCS3.*

NRW reserves the right to score independently for each breach where deemed appropriate in the future.

In line with our guidance, we may suspend scores for up to six months to allow time for remedial action to be taken. Suspended scores will be re-instated if the action is not completed.
