4. Details of our assessment

Self report received from Sam Taylor on 3rd October 2022. Volume of water entering both the Swansea Road, and Prince Charles silt management ponds was too great as a result of very heavy rain. This meant that water was released without full treatment causing visible silt pollution to the watercourse

Larger treatment system being designed. Site activities and silt management being reviewed to minimise volumes of silt water being produced. Potential to pipe clean water through site separately to be investigated.
