Received for 2018, all results are below the emission limit values set in the permit.

R1 Form

The waste per unit output (t/t) was twice that in 2017. The Operator comments state that a increase in waste generated on site is due to a fat spill of 16.18 tonnes contained within the mill and removed from site by Enviroclear. In addition, waste bags have had to go to landfill rather than recycling due to the waste contractor now accepting lower levels of contamination.

Action 1: Provide NRW with further information regarding the fat spill by the 28th of February 2019. Please include information regarding the cause of the spill, the impact and what measures have been put in place to ensure that this is not repeated.

Action 2: Provide NRW with a response to the following by the 28th of February 2019. Could another waste contractor be utilised for the removal of the waste bags?
