### Report assessments:

#### Response to CAR NRW0032923, received 23<sup>rd</sup> March 2018

An update on the permit application for the Part B permit with the Local Authority [Action1]. The water discharge permit application was also being progressed. Monitoring uncertainty confirmed for future returns [Action 2]. Actions complete.

#### Response to CAR NRW0033756, received 30<sup>th</sup> August 2018

Action 1: Dust control at entrance. NRW considers that the daily visual checks have not been sufficient in preventing dust tracking out of site. The proposals to carry out more road sweeping rather than wetting is acknowledged, however, NRW still considers that prevention of dust would be preferable. Maxibrite should consider options to reduce dust being carried out on vehicle wheels.

Action 2: Site traffic and spillages of material. It is disappointing that the design of the new part of the process has retained shovel loading. Options for containing localised spillages should be considered to prevent fines from entering the site water system. The move to more covered storage for raw material is good practise.

Action 3: Water monitoring. The proposals for a suite of determinands are acknowledged. This will be kept under review.
