### 4. Details of our assessment

During a routine compliance assessment check we have carried out on 11 January 2023 it was noted that the EDM returns for EPR permit BP0246601 CSO at 60 Metres D/S A487 Rd Bridge Aberaeron were missing from your 2021 EDM Annual Return.

The permit variation to add EDM conditions became effective on 21 October 2019 so, in accordance with permit condition 4.2.2, the annual EDM returns for this site should have been submitted in the 2021 return by the end of February 2022. Therefore a non-compliance occurred on 01 March 2022. We have used this non-compliance date at the top of the Compliance Assessment Report to enable accurate annual reporting.

Actions - please carry out the actions specified above to comply with permit condition 4.2.2.

It is an offence under Regulation 38(2) of the Environmental Permitting Regulations 2016 for a person to fail to comply with or to contravene an environmental permit condition.
