## 4. Details of our assessment

### **OMA audit 26<sup>th</sup> October 2022**

**Action 2A:** Improve and update training of all EnerSys personnel responsible for sampling and analysis. Discuss sample preservation, sample containers, labelling, chain of custody and packaging for transport with contractor. Review and update the relevant procedures. To be completed by 31<sup>st</sup> December 2022 and updated procedures sent to NRW.

**Action 4C:** Improve and update training of all EnerSys personnel responsible for sampling. Review and update the relevant procedures. To be completed by 31<sup>st</sup> December 2022.

Most aspects of actions 2A and 4C have been completed but evidence of training was incomplete. Updated training cards for EnerSys laboratory personnel were first received on 2<sup>nd</sup> December 2022 and the final version on 12<sup>th</sup> January 2023. The cards record the procedure, its version, the initial training date and the most recent training date and the procedure version used. They show that more than one person has been trained in the relevant procedures. They are now comprehensive records which should be easy to keep up to date.

**Actions 2A and 4C have been completed and can therefore be closed.**

### **CAR\_NRW0040027 Action 1: Audit supplier of red lead (Pb). To be completed by 31<sup>st</sup> December 2022.**

EnerSys receive monthly deliveries of red Pb. Audits had been carried in 2022 but documentary evidence could not be found. EnerSys completed an audit of a delivery on 6<sup>th</sup> January 2023 and the report was sent to Natural Resources Wales. There were no non-conformities and one opportunity for improvement was raised.

**Action 1 has been completed and can therefore be closed.**
