Site inspection on 16th April 2015 concentrated mainly on current permit regarding list of acceptance materials listed on current permit and on exemptions for storage of waste on adjoining site which is not part of the permitted area.

It was agreed that an application be made to NRW to add additional waste types to the existing permit, there were under 5 criteria and so it would be a minor admin variation only.

It was agreed that an S2 exemption be applied for re the adjoining site used for storage of separated waste types.

Visual inspection of site did not reveal any breaches.
