The form was received on 13<sup>th</sup> January 2023. It confirms that the installation continued to comply with the low impact installation criteria until it was destroyed by fire. The report is accepted.

### **Form Performance 1, 2022**

The form was received on 13<sup>th</sup> January 2023. The mercury recovery apparatus did not operate in 2022 and so there is no data to record.
